

Dear Member of the European Parliament,

We are a coalition of women's rights organisations from across the European Union, bringing together expertise in gender equality, violence against women, policy advocacy, high-level research, service provision and civic participation. Through the MOTERIS project, we are examining the challenges that women's rights organisations are facing and the implementation of women's rights across Europe. Our findings reinforce the importance of ensuring that women's rights and equality between women and men remain visible and adequately resourced priorities within the future EU budget.

The European Union has made significant commitments to equality between women and men, equal treatment and fundamental rights through its legislation, strategies and policy frameworks. Delivering on these commitments requires strong and sustainable women's rights organisations. Across Europe, these organisations provide essential services, monitor progress, advocate for change and help ensure that EU commitments translate into real improvements in the lives of women and girls. Their key role in advancing equality, preventing violence against women and supporting victims is recognised in the EU Directive 2024/1385 on combating violence against women and domestic violence. They also contribute to implementing the Gender Equality Strategy 2026-2030.

We are concerned that within increasingly merged funding frameworks, such as the proposed AgoraEU programme, support for women's rights, eliminating discrimination based on sex, promoting substantive equality between women and men risks becoming less visible and less accessible, at a time when many organisations are already facing increased demand for services, shrinking national funding, and growing opposition to women's rights across Europe. Women make up more than half of Europe's population, and the European Union has a legal obligation to promote equality between women and men across all policy areas.

As the European Parliament helps shape political priorities and ensures democratic accountability throughout the MFF process, it is essential that funding for women's rights, non-discrimination based on sex, equality between women and men, and combating violence against women remains visible and is not diluted within broader funding instruments.

### **We Call on Members of the European Parliament to:**

- Defend allocation and monitoring of budgeting taking into account the distinct needs of women and girls, mainstreaming the principle of equality between women and men across the EU budget cycle, and require regular reporting on spending and results related to gender budgeting commitments;
- Oppose the integration of funding for women's rights into broad, non-earmarked and generic funding envelopes that make tracking and access more difficult;
- Ensure that DAPHNE funding stream - within or outside of CERV+ - is defined and ringfenced as addressing exclusively violence against women and girls, and not broad categories or other groups affected by gender based violence.
- Ensure that specialist single-sex organisations providing services to female victims of discrimination and violence, including those supporting survivors of systems of prostitution, have equal access to EU funding within national and EU funding streams and will not become excluded in EU funding calls and project selection

- Promote multiannual operating grants and simplified access procedures for women's rights organisations, particularly small and grassroots organisations;
- Ensure that women's rights and equality between women and men remain visible priorities within future EU funding programmes.

**Additionally, in the coming negotiations on the MFF and the future architecture of EU funding programmes, we encourage Members of the European Parliament to:**

- Table and support amendments that safeguard visible and dedicated funding for women's rights and equality between women and men;
- Raise these priorities in committee discussions, political group deliberations and interinstitutional negotiations;
- Engage with women's rights organisations and specialist service providers to ensure that funding instruments respond to realities on the ground.

We welcome the opportunity to further contribute our expertise and evidence to the work of the European Parliament, including through meetings, hearings, roundtable discussions and input on relevant proposals concerning women's rights and equality between women and men.

The future EU budget must reflect and prioritise EU values and commitments to women's rights, equality between women and men, fundamental rights and democracy.
